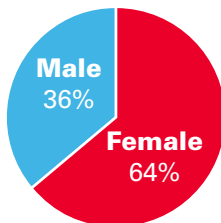

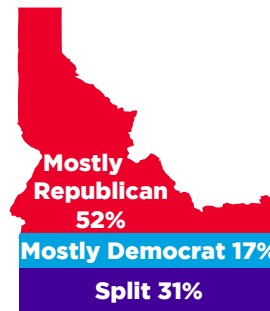

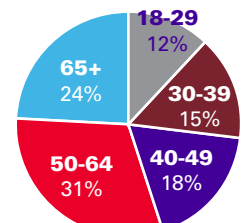

Gender



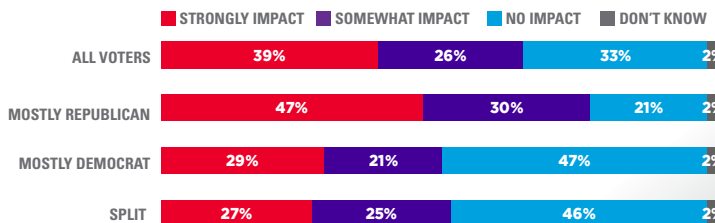
How did you mostly vote in the November election that just occurred?

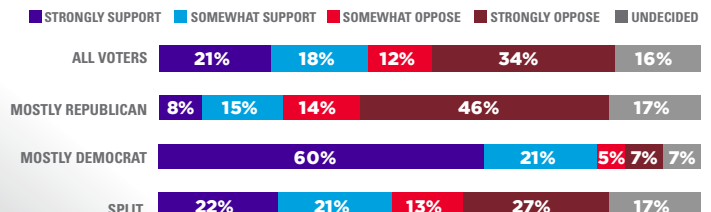
## ObamaCare Impact

How much did your views on the federal Affordable Care Act, known as ObamaCare, impact who you voted for in the November election?



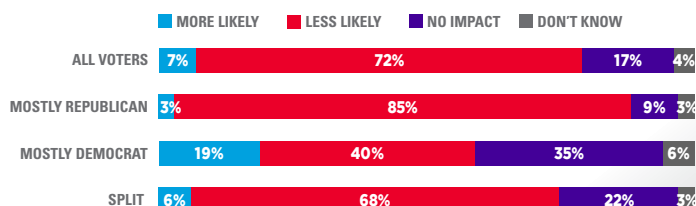
## Expansion 1st Ask

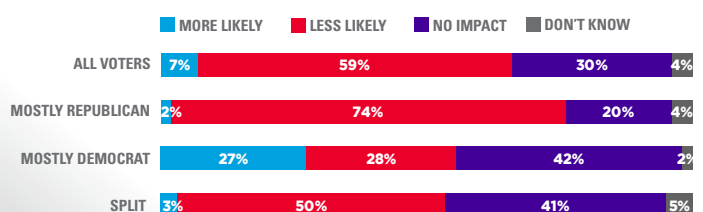
## Cuts to Seniors

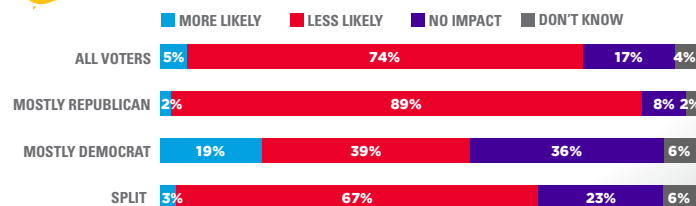
## Ex-cons

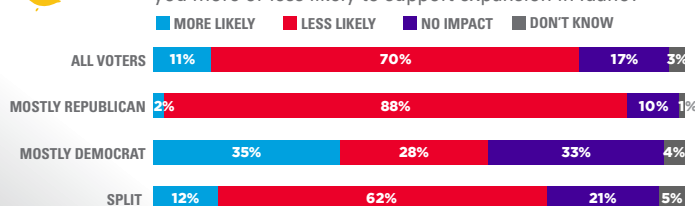
## Cuts to Priorities

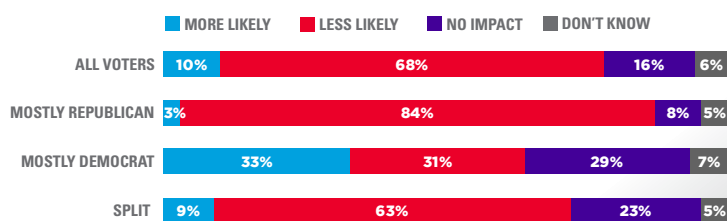
## More Spending

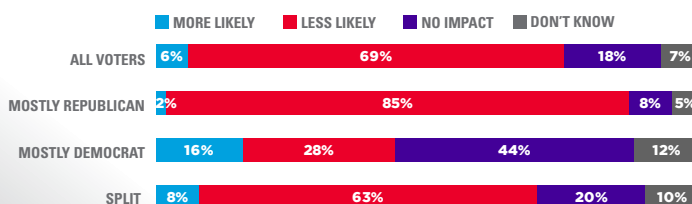
## No Way Out

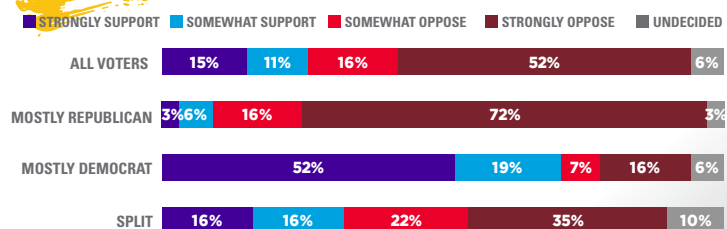
## Shrink Economy

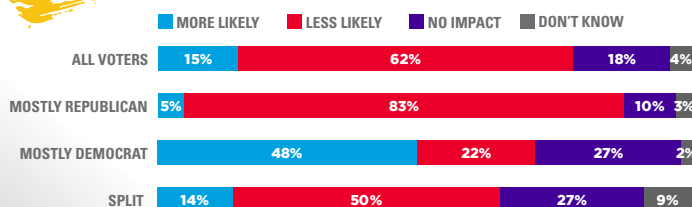
## Expansion 2nd Ask

Knowing what you know now, do you support or oppose expanding Medicaid in Idaho?



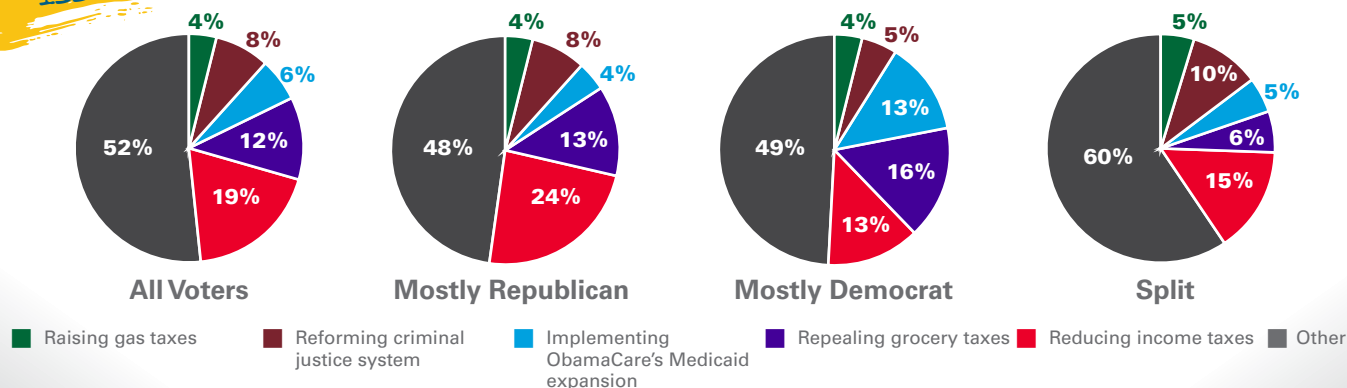
## Reelect

Results for this poll are based on live telephone interviews conducted among a statewide sample of 504 adults who voted in the November 2014 general election in the State of Idaho. Data for this survey research was collected by Advantage, Inc.

Interviews were conducted via a computer-assisted telephone interviewing system by professional interviewers who are extensively trained in interviewing practices, including techniques designed to achieve the highest possible respondent cooperation.

The surveys were conducted January 9-12, 2015. Survey questions and response options were rotated and randomized in order to ensure survey integrity. The margin of sampling error is plus or minus 4.36 percentage points. The margin of sampling error may be higher for certain subgroups.

Data is sampled using weighted demographic information from the U.S. Census Bureau's Current Population Survey Voting and Registration Supplement. Demographic information for actual voters in prior Congressional elections were used to construct sample target weights.
