- (a): 'IFF', 'our', 'us', 'we': Idaho Freedom Foundation, a 501(c)3 non-profit corporation, within the state of Idaho.
- (b): 'You', 'Your': A person, entity, corporation, body, assembly and/or authorized agent.

YOUR RIGHTS

This privacy policy set forth discloses the privacy practices for www.IdahoFreedom.org (herein referred to as the 'website') This privacy policy only applies to information and data collected by this website. This policy will notify you of the following:

- What personally identifiable information is collected from you through this website, how it is used and with whom it may be shared.
- What choices are available to you regarding the use of your data that is collected from this website.
- How you can correct any inaccuracies in any information collected from this website.
- The security procedures in place to protect the misuse of your information.

IFF is the only owner of the information contained and collected on this site. While we employ 3rd party vendors to assist in the user experience on our site, they are bound to the privacy policy set forth here on our website, www.IdahoFreedom.org. We only contract with 3rd party vendors that honor the integrity of our users data.

We collect information that you voluntarily give us via email and other forms of direct contact from you. It is our policy not to sell, rent, lease or otherwise distribute that information to anyone. We use your information to respond to you when, in the event, **you** contact us. Unless you ask us not to, we may contact you via email in the future to tell you about updates concerning our organization, which may include new products and/or services, and additional changes to this privacy policy.

You have the right, at any time, to opt out of any future contact from us. You may opt out at any time by contacting us via the email address and phone given on our website. Additionally you may request to see what data we have about you, change or correct any data, have us delete any data we have about you or express any concern you have about use of your data.

DATA SAFETY AND ENCRPYTION

When you submit information or data to our website, we take extra precautions to protect your information. When you submit sensitive information to our website, your information is encrypted and transmitted to us in a secure way. We use vendors that employ **PCI compliant 256-bit encryption** for both gathering of data, electronic mail use and credit card data submitted to our site. Our payment processor, Anedot, uses the highest means of data encryption currently available to keep your information secure. Our electronic mail provider uses the highest means of encryption available to keep your information secure. We have access to your name, e-mail address and other personal information, that you provide to us (with your submission of information to us through the website). This information is limited, however, to your name, address, city of residence, state of residence and ZIP code. We do not store personally identifiable information related to your social security number, credit card number, debit card number, security keys, password, username or any other sensitive personally identifiable information for one time payments or recurring payments. Our payment processor, Anedot, authorizes one time payments through our website but does not store that information for future use. Anedot, uses a proprietary encryption process which masks personally identifiable information (such as credit/debit card information) from *us* and Anedot. Anedot, will provide options for you to submit recurring donations *to us*, however that information is

unavailable to us and is only used at your request for payment processing through our site and our payment processor Anedot. Persons that choose to use the recurring payment option through Anedot should be aware that, the computers in which we store personally identifiable information are kept in a secured environment and are not accessible to our staff or that of Anedot. You may at any time, request that, we (through our payment processor, Anedot) suspend or eliminate the personally identifiable information used to submit recurring payments to *us*. All information that is transmitted through Anedot is encrypted and is inaccessible to both *Anedot and us* through a proprietary encryption process employed by *us* and Anedot.

PROCEDURES REGARDING YOUR PRIVACY

As stated above, we partner with another party to provide credit and debit card processing listed on our website. When a user signs up for these services, we will share names, or other contact information that is necessary for the third party to provide these services. However, these parties are not allowed to use personally identifiable information except for the purpose of providing credit and debit card processing.

As stated above, we partner with another party to provide electronic mail services or bulk electronic mail services listed on our website. When a user signs up for these services, we will share name, or other contact information that is necessary for the 3rd party to provide these services. However, these parties are not allowed to use personally identifiable information except for the purpose of providing electronic mail services or bulk electronic mail services.

As stated above, our payment processor Anedot, is a 3rd party credit card payment processing company that bills users for payments sent to us. Anedot does not retain, share, store or use personally identifiable information for any secondary purposes beyond processing your payment to us through our website.

As stated above, Anedot, uses a proprietary encryption process which masks personally identifiable information to them and *us*. Persons that choose to submit recurring donations, through Anedot, to *us*, should understand that Anedot will provide those services only with the consent of the user.

Our payment processor Anedot, uses an order form, and in addition, acts as a payment gateway for *us*. To process a payment to us, you must provide contact information (like name and billing address) and financial information (like credit card number, expiration date). This information is used for billing purposes only and is not shared with Anedot for the purposes of marketing, renting, selling or leasing of that information.
