### DEFINITIONS:

- (a): 'IFF', 'our', 'us', 'we': Idaho Freedom Foundation, a 501(c)3 non-profit corporation, within the state of Idaho.
- (b): 'You', 'Your': A person, entity, corporation, body, assembly and/or authorized agent.
- (c): 'The' 'system', 'system': An electronic secure database used to transfer funds authorized for withdrawal by a user to IFF.
- (d): 'Not-for-profit(s)': An IRS section 501(C)3 incorporated organization.
- (e): 'Debit': An electronic transfer of funds by an authorized agent from a draw account.
- (f): 'Correspondence': Notifications or text sent 'you' from 'us' via electronic mail or physical mail concerning you donation.
- (g): 'Tax receipt': Official correspondence to 'you' from 'us' concerning your donations made to us.
- (h): 'Payment': See 'debit'.
- (i): "Refund": A reversal of a transaction requested by an authorized user originally submitted to 'us'.

(1) Idaho Freedom Foundation (**IFF**, an IRS section 501(c)3 educational organization) will **refund your payment or donation**, within a 120-day period of the original transaction date, *for any reason*. If you are not 100% satisfied with your original donation or payment, we will fully **refund** your original donation amount within 5 business days. Before making your donation with our **system**, please read our **IFF Privacy Policy** to insure you understand how we will process your donation **our website**.

(2) Donors of **IFF** requesting a return of funds submitted to our **payment system** (herein referred to as '**the system**') will be returned depending on your original **payment** method process:

- A. If you processed your payment (or donation) via electronic (credit or debit) card through our **system**, **refunds** will be sent to the card-issuing bank within 5 business days of receipt of the return request or cancelation request. We will submit a return confirmation to you via electronic mail or, if electronic mail is unavailable, by physical letter (via the United States Postal Service) to your address on file, notifying you of your requested return.
- B. If you processed your payment via our E-Check our Automated Clearing House payment processing **system** (herein referred to as '**ACH**'), **refunds** will be sent to the originating checking or savings account originally authorized by you for us to draft from.
- C. If in the event your original payment form is unavailable for a payment **refund**, we will issue you a physical check, mailed to the address on file, within 7 business days.

(3) **IFF** is governed under 26 U.S.C. § 501(c) of the Internal Revenue Service's regulations concerning *charitable organizations*. **IFF** falls under 26 U.S.C. § 501(c) subsection 3, which describes **not-for-profits** in several different categories, *Religious, Educational, Charitable, Scientific, Literary, Testing for Public Safety, to Foster National or Amateur Sports Competition, or Prevention of Cruelty to Children or Animals Organizations*. **IFF** is, specifically, a 501(c)3 **educational non-profit** corporation, registered in the State of Idaho as Idaho Freedom Foundation Inc. Donations submitted to **IFF** are tax deductible and require that we follow certain reporting requirements set forth by the Internal Revenue Service found in the Code of Federal Regulations under 26. U.S.C. When you donate to **IFF** we will do the following items:

- A. We will submit your payment through our **system** in accordance with your request that we **debit** (ACH or **system** payment) your account for the amount of funds you request.
- B. We will confirm your payment through electronic mail (if available), and mail through the United States Postal Service. The **correspondence** we send **you** from **IFF** is an official receipt of your transaction through our **system** or **ACH** payment **system**.
- C. At the end of the calendar year (in which the donation is made) we will send you a **tax receipt** letter that serves as your official tax statement that is submitted to the Internal Revenue Service for your taxes from the previous calendar year.
- D. **Tax receipt** statements are sent out in January of a new calendar year for the prior years donations made through our **system**.

(4) If in the event you require a **refund** from a previous calendar year donation, in a new calendar year, and have already received a **tax receipt** from IFF, we will gladly **refund** your donation within 120 days of the original transaction. We will return your donation, as described above in paragraph 2, sections A – C. We will also send you a revised **tax receipt**, to you, for the previous calendar year. It is your responsibility to accurately correct and report, to the IRS, any changes with submitted or previously submitted IRS individual or corporate tax returns. We are more than happy to facilitate quick response to your needs whatever they may be and again we offer a 100% satisfaction guarantee with your donation.
